### **Instructions for Identification of Race and Ethnicity**

#### **Ethnicity:**

- Hispanic or Latino (A person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin, regardless of race.)

#### **Race:**

- American Indian or Alaska Native (A person having origins in any of the original peoples of North and South America, including Central America, and who maintains tribal affiliation or community attachment.)
- Asian (A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Philippine Islands, Thailand, and Vietnam.)
- Black or African American (A person having origins in any of the black racial groups of Africa.)
- Native Hawaiian or Other Pacific Islander (A person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.)
- White (A person having origins in any of the original peoples of Europe, the Middle East, or North Africa.)

### **Instrucciones para la identificación de raza y etnicidad**

Las autoridades del Estado y el gobierno Federal requieren que el Distrito reporte la raza y etnicidad de cada estudiante para el año escolar. - Asiático (Una persona que tiene orígenes en cualquiera de los grupos de personas originales de Lejano Oriente, Sureste Oriente, o del subcontinente de India incluyendo, por ejemplo Cambodia, China, India, Japón, Corea, Malasia, Pakistán, las Filipinas, Tailandia, y Vietnam.)
- Niegro o Africano Americano (Una persona que tiene orígenes en cualquiera de los grupos de raza negras de África.)
- Nativo Hawaiano U Otro Isleño Pacifico (Una persona que tiene orígenes en cualquiera de los grupos de personas originales de Hawai, Guam, Samoa, u otra isla del Pacifico.)
- Blanco (Una persona que tiene orígenes en cualquiera de los grupos de personas originales de Europa, del Oriente Próximo, o Norte África.)
